



**Location Contract  
Location Usage Agreement**

[OWNER ] (hereinafter referred to as "owner") hereby grant to  
[FULLNAME ] (hereinafter referred to as [NAME]), his/her  
successors, assigns and licensees, the right to photograph, reproduce and use (either accurately or with  
such liberties as they may deem necessary) the exteriors and interiors of the premises located at  
[ADDRESS

and to bring personnel and equipment onto the premises and remove the same By this agreement, we grant  
you possession of the premises on  
[DATE ], and may continue in possession thereof until the completion  
of your proposed scenes and work, requiring  
occupancy over a period of [NUMBER ] days.[NAME] should be finished filming on said premises by  
[DATE ], and will leave the area in the condition in which it was  
originally found with exceptions as specified by this agreement. However, in the event of the incapacitation  
of actors, director, or other essential artist or crew, adverse weather conditions, or any other occurrence  
beyond the control of [NAME], that prevents starting or completing work on or by the previously designated  
dates, or in the event of damaged or imperfect film or equipment, The owner agrees to the best of the  
owner's ability to accommodate [NAME] in granting the right to use the premises at a later date to be  
mutually agreed upon.

This grant of location rights is in connection with the motion picture photo play tentatively entitled  
[TITLE ], and includes the right to re-use the photography in  
connection with other motion picture photo plays as you, your successors, assigns and licensees shall elect,  
and, in connection with the exhibition, promotion, advertising and exploitation thereof, in any manner  
whatsoever and at any time and in any part of the world. Similarly, [NAME] agrees to hold the owner free  
from any claims for liability, damage or injury arising during occupancy of the premises and arising out of  
your negligence thereon on the aforementioned dates; [NAME] further agrees to leave the premises in as  
good order and condition as when received, excepting reasonable wear, tear, force majeure, and use. The  
owner acknowledges that, in photographing the premises, [NAME] is not in any way depicting or portraying  
the owner in the motion picture photo play, either directly or indirectly. The owner guarantees hereto that he  
will not assert or maintain against [NAME] any claim of any kind or nature whatsoever, including, and without  
limitation, those based upon invasion of privacy or other civil rights, defamation, slander or libel, in  
connection with the exercise of the permission herein granted. Further, the owner represents that  
he/she/they is/are the actual and legal owner(s) and/or authorized representative(s) of the premises, and  
thereby has the authority to grant to [NAME] by pen the permission and rights herein specified, and that the  
permission of no other party is required.
